- Promotion of projects, the development of activities to increase the presence of the company in the commercial market giving priority to preventive measures to reduce/avoid work-related illnesses or injury;
- Active promotion and dissemination of an extensive awareness of risks and measures for the accident prevention through participation in training courses as well as disposal of information, instructions and directives. This should motivate employees to pay attention and comply with the Safety management; they should not expose themselves or other workers to dangers, which could cause injures or be damaging for themselves;
- Observance of Health and Safety Management Standards ISO 45001, maintaining the relevant certification.
